STALLION SERVICE CONTRACT 2016

This contract certifies that _____, (herein referred to as The Mare Owner), has entered into this contract with Gala Stud (herein referred to as The Stallion Owner), for breeding to the Quarter Horse Stallion **Genuine Cowhouse Ich** (IMP) 4954372 (AQHA Aust. Q79351)

for the Mare _____ Reg # _____, Breed _____, for the 2016 breeding season, for a service fee of \$1000.00, plus any pre-discussed charges.

A \$200.00 non-refundable / deductible booking fee, per mare booked, is payable upon signing this agreement. (The booking fee will be deducted from the stallion service fee.)

This service is subject to the following terms and conditions:-

1. SHIPPED SEMEN – The Stallion Service fee less any discounts is to be paid in full and a copy of mare's papers, and 2 copies of the signed contract executed by the mare owner, along with a clean swab report, to be received by Gala Stud before semen is shipped. *This is required to maximize the chance of positive insemination results.*

Gala Stud will sign and return a copy of the contract to the mare owner, prior to shipping semen.

The mare owner must advise Gala Stud at least **7 days notice** prior to anticipated time of insemination to allow timely shipping of semen.

The stallion owner agrees to ship enough semen for 1 mare on one day inclusive of stallion service fee.

The mare owner or veterinarian must return the shipping container within 24 hours of receiving or a daily rate of \$30.00 will be charged to the mare owner.

The mare owner will be charged \$200.00 for any subsequent semen shipments required.

The mare owner agrees to breed only the mare booked and not use the semen to breed any other mares, unless otherwise agreed to by Gala Stud. In the event the mare to be bred does not settle, the mare owner will hold the stallion owner blameless. The mare owner agrees to have a licensed veterinarian or certified A.I. Technician inseminate the mare and fill out the appropriate association paper work, and return.

Please check with your association with regard to the use of a certified A.I. Technician prior to the insemination of your mare.

Gala Stud, stores frozen semen at this facility to inseminate mares at the centre. The mare owner shall send the contract back signed, with all correct information filled out, accompanied by the Stallion Fee. The mare owner is responsible to ensure that the mare to be bred is properly prepared for breeding. This shall include a **clean swab report** from a **licensed veterinarian**. Mare should be cycling properly. The mare owner's veterinarian must monitor the above mentioned mare for ovulation and when follicle 3.5cm deliver mare to Hawkesbury Equine Veterinary Centre for artificial insemination then taken home by owner. Mare should be scanned for pregnancy at 14-18 days.

The mare owner agrees to breed only the mare booked. In the event the mare to be bred does not settle, the mare owner will hold the stallion owner blameless.

The mare owner accepts full responsibility for the insurance of the aforementioned mare for the duration of her time at the centre. Whilst all care and consideration is taken, Hawkesbury Equine Veterinary Centre and or Gala Stud will not be held Responsible or Liable for any Injury, death or debilitation of the afore mentioned mare.

The mare owner agrees to complete the appropriate association paper work and lodge.

BREEDING SEASON AND GENERAL CONDITIONS APPLICABLE TO THE ABOVE.

The breeding season covered by this contract shall begin **September 1st, 2016** and end **December 24th, 2016** unless extenuating circumstances arise or by private treaty.

It is further agreed that should the above named mare die during the breeding season covered by this contract, the mare owner may substitute another mare.

A breeding certificate, where applicable, will be issued to the mare owner, only after all expenses have been paid in full, including and additional veterinary, agistment, shipping and collection fees where applicable. The **\$200.00 non-refundable** booking fee will be applied against the stallion service fee.

At the stallion owner's discretion, Gala Stud, may refund the refundable part of the stallion fee and terminate this agreement at any time.

LIVE FOAL GUARANTEE

Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a onetime return season will be guaranteed the breeding season immediately after you enter into contract with Gala Stud, providing proper notification is given. It is agreed that mares over 18 years old are ineligible for the LFG.

*** Proper notification shall be defined as follows:**

A **written certification** by a **licensed veterinarian** must be received by Gala Stud, within 5 days, that the mare has slipped or produced a non-viable foal. Live foal guarantee on the aforementioned stallion is as follows: Gala Stud will re-breed the same mare for a **\$FREE** return. A **\$200.00** "semen shipment fee" for each shipment to the mare owner or mare owner's veterinarian will apply.

The stallion owner may require the mare to be re-served at Gala Stud or an acceptable breeding centre.
